Resolutions & Ordinances

1. **Ordinance 11-04** - Introduce Title XIV - Platting – (handed out in Feb. packet)

Sara Yockey motion to introduce Ord. 11-04 Title XIV – Platting Ordinance. Elaine Price second.

Elaine Price explained this is being introduced to clarify some of the wording to reflect that in the future when anyone does any kind of a subdivision that has a road in it that needs to be permitted; the sub-divider shall pay for the permitting. This is time consuming and expensive for the city to have to do this. This will be addressed at the workshop.

2. **Ordinance 11-05** - Introduce Title II – Chapter 2.10 - Library
Elaine Price motion to introduce Ord. 11-05 – Title II – Chapter 2.10 – Library. Misty Fitzpatrick second.

Elaine Price explained the proposed changes are in the packet. We are no longer a combination school and public library. We are just a public library, so there's no sense in having a teacher on the board any longer. She would like to change the board from 5 to 7 members.

3. **Resolution 11-20** - AML/JIA – Loss Control Incentive Program

Just last week the Kake Tribe and a bunch of environmental groups filed suit to contest the Tongass National Forests exemption from the Roadless Rule. The Judge ruled in their favor and decreed the Tongass National Forest will now have to abide by the Roadless Rule with the rest of the country. We are not sure whether the Forest Service is going to file an appeal or what our delegation is going to do. We are in favor of an exemption from the Roadless Rule.

Representatives from Mental Health Trust have been talking to Elaine and others on the island. They have some land selections they are able to make

and they want to do some on Prince of Wales Island. They have gone from just wanting to export stuff to actually manufacturing in Southeast Alaska. They have been working with Clarence Clark and the Department of Natural Resources to come up with some sort of a stable base for small mills and Stuff with the available timber that's there. This Resolution is to show the community's support of this land selection.

Sara found some information on-line. Most places rent space by the square foot. This will be a topic for discussion at the next workshop on May 5th.

3. Request to remove 1 service from downtown lot - John Rodriguez

There was much council discussion on this issue. There was nothing found in the Water/Sewer Ordinance regarding this particular issue.

Elaine Price motion to allow John to take out the water/sewer service to the trailer, and when the trailer is removed, from that point on the city will charge just a stub-out fee for that service. Carolyn Duncan second.

It was explained there will be 1 full service and 1 stub-out for this lot.

4. Post Office Remodel - there has been no answer as of yet from the Post Master in Ketchikan. This will be on next month's agenda.

New Business

1. Alcoholic Beverage Control Board Renewal Application Notice – Rain Country Liquor - no objections to this renewal

2. Gas Station Update - Ron Rusher - (this was moved up from number 5)
Ron explained he is looking at card swipe pumps. He will be pouring concrete and will be moving across the road before the paving project starts.

3. Fireworks - Fire Department - it was recommended these be ordered by next month to get a good start on this. The plan is to have everything sold by July 4th. Misty Fitzpatrick will order starting next week. The plan is to sell at least once a week till closer to the 4th. Elaine will give Misty the name and address of the people we ordered from last year.

4. Biomass - Wood Boiler? - Elaine brought the brochure for this to council. This boiler has the capacity to provide power for the industrial site being put in out the road and if it ever became necessary to provide power for the city as well. According to Beth Pendleton the State Forester there is lots of grant money available for the timber industry in Southeast at this time. The timing could be right for this. Elaine will take this information to D.C. with her to talk to Lisa Murkowski. Elaine is checking to see if this will also burn garbage. If it will it will save the city money, with the future possibility of providing revenue for the city.

5. Buried telephone lines – Liquor Store to Post Office
Alaska Communication Services engineer was here a few weeks ago at Ron’s request. There’s a power pole that sits at the corner of his property, right across from the gas station, that he would like moved. Ron had asked them to move the pole or eliminate it but the line is functional and needs to remain. Ron asked if the line could be buried. The telephone company said they could do that but Ron would have to pay for the whole thing. Elaine asked Randy Wright to give the city a quote on what it would cost for the coax and burying the conduit. The quote came out to right around \$5000 for everything. When Elaine told Ron, he asked if the city would buy the conduit he would do the work with the city backhoe at no charge.

Elaine Price motion the city pay for the conduit and work with Ron Rusher to bury the line. Misty Fitzpatrick second.

Public / Council Comment - Misty asked if council wanted her to make the Coffman Cove Alaska sign for the harbor. Elaine stated yes, but we need to let Larry Burrows know that he's not doing it and we need to also let him know we are not doing any more maintenance, and since the dumpster locks have never been done (he was supposed to do that) Elaine would like to just hire Clayton Smalley to do it and have it done. Misty stated yes, let's do it. Misty will do the sign for the harbor.

Elaine wanted to talk about the on-call list. It's not appropriate for employees to call people from the on-call list and put them to work. Any time anyone needs help they need to contact the office for authorization and the work will be dispatched from there. There will be a clear outline of regular duties put together.

Howie and Raylene Arntzen are going to pay for the 911 radios.
