

## **CITY OF COFFMAN COVE**

### **RESOLUTION 20 08**

#### **A Resolution declaring supplies and equipment previously owned by the North End Ferry Authority as surplus property of the City of Coffman Cove**

**WHEREAS**, the city of Coffman Cove passed non-code Ordinance 12-04 as a guideline for the sale of surplus property; and

**WHEREAS**, Non-Code Ordinance 12-04 states that supplies, materials, equipment or other personal property, estimated by the Mayor to be in excess of two thousand five hundred dollars (\$2,500.00), which are obsolete or no longer required for city purposes may be disposed of as surplus property in the manner provided by resolution of the assembly declaring such property as surplus and prescribing the method of disposal; and

**WHEREAS**, methods of disposal may include, but are not limited to:

1. Exchange the same for, or apply the same against, new supplies, materials, equipment or other property.
2. On the open market by telephone solicitation, written quotation or competitive bid.
3. Exchange, donation or transfer to another governmental unit, or to a charitable, civic or non-profit organization.
4. By public auction. The manager shall promulgate rules for the conduct of the auction. No auction shall be without reserve unless prior to the auction it is announced to be without reserve.
5. Abandonment, destruction or other means of disposal; and

**WHEREAS**, the supplies and equipment currently stored at the Coffman Cove Ferry Terminal has an estimated resale value of at least \$2,500.00; and

**WHEREAS**, an inventory of items is as follows:
